

Belton Community Garden Information and Application



Overview

The Belton Community Garden was established in July, 2015, and is located at Heritage Park– 100 Park Avenue, Belton, TX 76513. The Garden is comprised of 39 garden plots which are _8_ ft x _4_ ft.

Plots will be available to citizens of Belton, with all membership requests requiring the applicant to show proof of residency within Belton city limits. There are no fees associated with being granted a plot; however, members must adhere to the Garden Rules, and commit to participating in a Spring and Fall cleanup day each year.

All requests for plots at the Community Garden are to be made at the Belton Parks & Recreation Office– 401 N. Alexander St, Belton, TX, 76513.

The Citizens Committee is a subcommittee of the City of Belton Parks Board. Committee members are appointed by the Parks Board, and will serve 1 year terms , beginning January 1st of each year.

The Committee will oversee day-to-day operations of the Garden, along with notifying City staff of any maintenance needs, and resolving complaints, issues, or disputes between Gardeners.

Community Garden Rules

1. You must live within the city limits of Belton. Proof of residency will be required.
2. Plot assignments and locations will be given on a first come first serve basis.
3. Keep your plot clean, help maintain paths and fence lines.
4. Watering, weeding, harvesting and any other garden related maintenance is your responsibility.
5. Conserve water, don't waste it.
6. No pets will be allowed in the garden.
7. Children must be supervised at all times.
8. No chemical fertilizers, insecticides or weed repellents will be allowed.
9. You are asked to adhere to organic growing practices.
10. Discourage theft; harvest promptly.
11. Do not pick from other plots.
12. Do not share the combination lock number with anyone.
13. You are responsible for trash removal.
14. Smoking, chewing tobacco, e-cigarettes, and open flames are not allowed.
15. Park hours will apply to Garden– 5:00AM to 11:00PM.
16. Must be at least 18 years of age.
17. Plots will be granted for a 1 year term, beginning January 1st of each year.
